## General Meeting: November 19, 2019. 7PM

Speakers: Joanne Ryan

**Topic:** All but lost – The Waters/House Sugarhouse in Sienna Plantation

The November meeting will focus on sugar production in 19<sup>th</sup> century Ft Bend County. "All but lost - The Waters/House Sugarhouse in Sienna Plantation" will be presented by Joanne Ryan - an archeologist who is very active in Louisiana where sugar is still an important crop. Joanne has excavated multiple sugarhouses and is considered an expert on the subject. Due to the fact that Fort Bend County has the last remaining antebellum sugar purgery, Joanne has partnered with avocational archeologists in Fort Bend so that the site could be better documented and understood, and at this meeting Joanne will present information on this structure as well



as previous excavations at similar sites in Louisiana. This site is a standing artifact to that period of Fort Bend's history.

Joanne Ryan is an Archaeologist, Historian and Project Manager for Coastal Environments, Inc., where she has worked for 25 years. She received her B.A. in Classical Archaeology from the University of North Carolina, Chapel Hill in 1986, and an M.A. in Archaeological Studies from Yale University in 1988. Ryan has extensive experience in the large-scale excavation and interpretation of industrial archaeological sites, particularly plantation sugarhouses, municipal waterworks, and commercial brickyards. She has conducted cultural resources investigations in Alabama, Louisiana, Mississippi, North Carolina, and Texas.
