Topic: Tobacco in Texas: and the problem of Ephemera



This talk will feature an overview of the agriculture, manufacture, and consumption of tobacco products in Texas. We will discuss some common misconceptions about tobacco-related artifacts, using this to highlight archaeological problems in regards to disposable and biodegradable material culture.

Bio: *Ross Arlen Tieken* is a writer & tobacconist from Shiner, Texas, currently living in Houston. After receiving a Master's degree in Religious Studies from Rice University, he turned back to his roots: the living, embodied culture of Texans. He currently works at the Briar Shoppe, the oldest tobacconist in Texas, and is in the process of writing his first full-length book.
