# New Lab Facility at the San Felipe de Austin State Historic Site Speaker: Bryan McAuley

San Felipe de Austin, founded on the banks of the Brazos River in the fall of 1823, lived a dynamic and engaged existence – hosting practically every prominent figure connected to the Mexican Texas era – before it was sacrificed during the Texas Revolution, burned to the ground as part of a military strategy after its residents were evacuated ahead of Santa Anna's advancing army. Since 2008, the Texas Historical

Commission has been committed to reviving the important stories and events of the town's brief life. Site Manager Bryan McAuley will project what his team hopes their upcoming lab facility will allow them to do.

Bryan McAuley holds a BA in government/anthropology from the University of Texas at Austin and an MA in political science/sociology from Texas State University in San Marcos. He has worked in the museum field since 2000 with posts at the Texas Independence Trail

Region, the Fort Bend History Association and, since 2008, with the Texas Historical Commission (THC). Since the initial sites transfer to the THC, Bryan has been part of the project team planning for visitor experiences at San Felipe de Austin State Historic Site – set within the footprint of the headquarters of Stephen F. Austin's Colony in Mexican Texas.

## **Field Notes**

**Excavation Site** - FBAS volunteers continue to investigate a historic homesite near Richmond. Want a closer look? We dig every Saturday morning and welcome all new volunteers - come join us, or just come out to watch!







In late March, we found the fourth corner of the root cellar where we expected it to be based on the location of the other three. With the discovery of the fourth corner, we can confirm the size and shape of the root cellar. We now want to take a close look at the cellar along its east wall. We opened a new pit to investigate the wall. In the top left photo, Bruce Grethen can be seen laying out the new pit. Once down to the historic occupation level, we started finding some interesting artifacts. The top right photo shows both sides of a sherd of terracotta pottery with an interesting pattern on it. Terracotta is an unusual find for us on this site.







The ceramic sherd in the photo above is also very unusual. The photo shows both sides of the piece with its interesting patterns. Hopefully, we'll locate more pieces as our investigation continues. A couple of weeks ago, we unintentionally captured this shrew in one of our pits. This is only the second time we've ever seen one. It looks a lot like a mouse, but shrews are not rodents. In fact, shrews are a much closer relative of hedgehogs and moles. John Rich captured the shrew and released him nearby.

## **Texas Historical Commission**

### **Archeological Stewards** – Two FBAS

members made the news recently in a program of the Texas Historical Commission. The Texas Archeological Stewardship Network is a group of trained and motivated avocational archeologists who work on a volunteer basis representing the state. Stewards help find, record and monitor archeological sites in Texas. The Texas Historical Commission (THC) has the responsibility to preserve and interpret the vast archeological landscape of Texas. The staff is dedicated and capable, but with a small staff of archeologists, they need help in tackling this huge job. In 1984, the THC created the Texas Archeological Stewardship Network (TASN).
