Topic: Investigations of Early Norwegian Settlers on the Texas Frontier Discover the Home of Cleng Peerson



The search for the home of Cleng Peerson, founding father of Texas's earliest Norwegian settlement in Bosque County, began when a curious landowner contacted the Texas Historical Commission (THC) History Division. Members of the Texas Archeological Stewards Network (TASN) began field investigations and consulted with staff in the Architecture and Archeology divisions. After extensive archival research and excavations, TASN members verified that Peerson acquired 320 acres outside of Clifton in 1859, had given 160 acres to Ovee Colwick in 1860 in exchange for a place to live and be cared for in his final years, and the landowner was indeed living on property that contained the remains of the

homestead. Excavations revealed the remains of a stone house with an earthen walled cellar. The floorplan aligns with the 1896 insurance documents of the Colwick home. Numerous family histories share the story of Peerson's commitment to the community and provide pictorial evidence of the various construction phases of the house through multiple generations of the Colwick family. In 2015, the homestead was nominated and subsequently listed to the National Register of Historic Places (NRHP) because of its potential to yield important information regarding the acculturation of a relatively isolated immigrant community which is underrepresented in the archeological record. A summary of the archival research, field investigations and NRHP nomination process will be presented.

Becky Shelton received her Master's in Anthropology from the University of Texas, Arlington in 2008. Currently Becky is a THC regional archeologist where she provides technical reviews on state and federal undertakings related to the Antiquities Code of Texas and Section 106. Within the Archeology Division, she works with landowners and consultants to preserve significant archeological sites and assists with providing protective designation. In addition, she assists in promoting Historic Texas Land Plaque program, handles public inquiries and requests concerning archeological issues, and coordinates with regional archeology societies. She also participates in archeological investigations, conducts site evaluations and analysis, and prepares reports on the results of these investigations.
